Appendix: Double Your Cash promotion

PLEASE SEE THE ADVISOR ESCAPE PROMOTION OFFICIAL RULES FOR DEFINITIONS, QUALIFICATION DETAILS, TERMS AND CONDITIONS AND GENERAL PROVISIONS.

DOUBLE YOUR CASH

As included in the Official Rules, “Resort Stays Described,” Advisors will receive a cash stipend [paid by direct deposit after the Qualification Period (as defined in the Advisor Escape Promotion Official Rules) concludes] when they achieve one of the Escape Tiers and earn one of the corresponding Resort Stays.

During the Double Your Cash promotion period, Advisors will be eligible to double their cash stipend amount when they recruit the number of new Downline Advisors with join dates from January 3, 2023 to August 31, 2023 required under the minimum Team Building Points requirements for their goal Tier. The cash stipend will be paid in January 2024, after the Qualification Period ends if the Advisor also meets all minimum qualifications of the same Goal Tier.

The doubled cash amounts are shown below for each of the Escape Tiers for the United States, Canada and Australia.

Example 1: Sarah is a U.S. Advisor going for Sun-Sational. She currently has six new Downline Advisors who signed up in the qualification period. When she recruits four new Downline Advisors with join dates between July 14, 2023, and August 31, 2023, she will double her cash and qualify for a maximum \$3,000 USD stipend. She then has until 12:01am CT on January 2, 2024, to coach her new team members to Level 2 and complete the other Sun-Sational qualifications. If she successfully completes all other Sun-Sational qualifications by 12:01am CT on January 2, 2024, she will receive \$3,000 USD by direct deposit later in January.

Example 2: Barb is a Canadian Advisor going for Sun Riser. She currently has two new Downline Advisors who signed up in the qualification period. When she recruits two new Downline Advisors with join dates between July 13, 2023 and August 31, 2023, she will DOUBLE her cash and qualify for a \$1,300 CAD stipend. She then has until 12:01am CT on January 2, 2024, to coach her new team members to Level 2 and complete the other Sun Riser qualifications. If she successfully completes all other Sun Riser qualifications by 12:01am CT on January 2, 2024, she will receive \$1,300 CAD by direct deposit later in January.

When the Double Your Cash promotion concludes, the number of new Downline Advisors each Advisor has added to their team with join dates from January 3, 2023, to August 31, 2023 will determine the maximum eligible amount for the double cash stipend awarded under the Double Your Cash promotion.

When the Promotion Qualification Period concludes, the final Tier each Advisor reaches will determine the actual cash stipend paid. For example, if an Advisor achieved Sun Chaser double cash during the Double Your Cash promotion period and ultimately achieves the Sun Chaser Tier at the end of the Qualification Period, they will be paid the double cash amount for the Sun Chaser Tier (US\$2,000, CAD\$2,600, AUD\$3,000). Should that Advisor achieve a lower Tier at the end of the Qualification Period, for example the Sun Riser Tier, they will be paid the double cash amount for that lower Tier (e.g., US\$1,000, CAD\$1,300, AUD\$1,500 for the Sun Riser Tier).

Should an Advisor achieve a higher Tier at the end of Qualification Period than the double cash Tier at the end of the Double Your Cash promotion period, that Advisor will receive the original cash stipend amount for the Tier achieved at the end of the Double Your Cash promotion period and that will be added to the original cash stipend amount for the Tier achieved at the end of the Qualification Period. For example, if an Advisor achieved Sun Chaser double cash during the Double Your Cash promotion period and ultimately achieves the Sun-Sational Tier at the end of the Qualification Period, they will be paid the original cash stipend for the Sun Chaser Tier (US\$1,000, CAD\$1,300, AUD\$1,500), **plus** the original cash stipend for the Sun-Sational Tier (US\$1,500, CAD\$2,000, AUD\$2,200). Thus, it is best and most advantageous to achieve the Double Your Cash promotion for the highest tier you wish to earn for the Advisor Escape before the end of the Double Your Cash Bonus Promotion deadline of August 31, 2023.

The General Provisions stated in the Advisor Escape Promotion Official Rules shall also govern the Double Your Cash promotion.
